B. The Superintendent recommends adoption of the following:

RESOLUTION OF SUPPORT
EDUCATE OHIO
WHEREAS, the Ohio Constitution requires the state to secure a thorough and efficient system of common schools, and

WHEREAS, the Ohio Supreme Court has ruled Ohio's system of school funding unconstitutional four times, and

WHEREAS, the State Defendants were ordered to give the school funding system a complete systematic overhaul including the reduction of reliance on property taxes and the establishment of a rational basis for the school foundation program, and

WHEREAS, the state has failed to satisfy its constitutional obligation to provide and adequately fund a high quality public education for all of Ohio's children, including the children of this school district, and

WHEREAS, all political power is inherent in "We the people," and
WHEREAS, a constitutional amendment will establish public education as a fundamental right, and will establish a rational process to identify and cost out the learning resources inherent in a thorough and efficient system of public education, and will guarantee access to high quality educational opportunities for all students, and will substantially reduce reliance on property tax as a source of funding schools, and will require the state to provide adequate funding to ensure access to high quality educational opportunities for all students and will hold harmless all school districts at their current level of state and local revenue.

NOW THEREFORE BE IT RESOLVED that the Tuscarawas Valley Local Board of Education supports the passage of such a constitutional amendment and would encourage all students, faculty, staff and members of the public to support such a constitutional amendment, and directs the Treasurer to forward a copy of this resolution to The Ohio Coalition for Equity \& Adequacy of School Funding, 100 South Third Street, Columbus, OH 43215.
