 RESOLUTION DETERMINING TO PROCEED WITH THE SUBMISSION TO THE ELECTORS THE QUESTION OF THE RENEWAL OF AN EXISTING EMERGENCY LEVY PURSUANT TO ORC 5705.194 THROUGH 5705.197

The Board of Education of the Tuscarawas Valley Local School District, Tuscarawas County, Ohio, met in Regular Session on the 14th day of February 2005, at the offices of said Board, Zoarville, Ohio, with the following members present: Susan Kaschak, Richard Gooding, Chuck Knaack, Mark Porter, Ed Weaver.

The Treasurer advised the Board that the notice requirements of ORC 121.22 and the implementing rules adopted by the Board pursuant thereto were complied with for the meeting.

Mr. Gooding moved the adoption of the following resolution:

WHEREAS, on January 27, 2005, this Board adopted Resolution No. 1/10/05, requesting the Auditor for a calculation of the millage necessary to raise a specific number of dollars for the renewal of an existing levy as described below, a copy of which resolution was certified to the Auditor of Tuscarawas County; and

WHEREAS, that County Auditor has certified to the Board that the annual tax levy required throughout the life of the proposed levy to produce the annual amount of Four Hundred Sixty Thousand Dollars (\$460,000) as set forth in that resolution, calculated in the manner provided by ORC 5705.195 is 2.45 mills for each one dollar of valuation, which is twenty-four and five tenths (\$0.245) cents for each one hundred dollars of tax valuation.

BE IT RESOLVED by the Board of Education of the Tuscarawas Valley Local School District, Tuscarawas County, Ohio, a majority of all members of the Board concurring that:

<u>Section 1.</u> This Board determines and declares that the revenue which will be raised by all tax levies which this Board is authorized to impose, when combined with state and federal revenues available to this Board, will be insufficient to provide for the emergency requirements of the District, and that it is therefore necessary to levy a renewal of an existing tax in excess of the ten-mill limitation in order to raise the amount from the renewal of Four Hundred Sixty Thousand (\$460,000) each year for a period of five (5) years for that purpose. This levy renewal shall renew all of an existing levy.

<u>Section 2.</u> Pursuant to ORC 5705.194 to 5705.197, there shall be submitted to the electors of this District at the election to be held on May 3, 2005, the question of levying a renewal of all of an existing tax in excess of the ten-mill limitation for a period of five (5) years with a levy on the tax list and duplicate for the year commencing 2006, to be first distributed to the Board in calendar year 2007 to raise the amount of Four Hundred Sixty Thousand Dollars (\$460,000) from the renewal each calendar year for a period of five (5) years for the purpose of providing for the emergency requirements of the school District, at the annual tax rate necessary to raise that amount, which rate is estimated by the Tuscarawas County Auditor to be 2.45 mills for each one dollar of tax valuation, which is twenty-four and five tenths (\$0.245) cents for each one hundred dollars of tax valuation.

<u>Section 3.</u> The Treasurer is authorized and directed to certify immediately a copy of this resolution to the Tuscarawas County Board of Elections and the certificate of the County Auditor and request that the Board of Elections prepare the ballots and make other necessary arrangements for the submission of this question to the electors of this District, all in accordance with law.

<u>Section 4.</u> It is hereby found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were adopted in an open meeting of this Board and that all deliberations of this Board and of any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with law.

Mr. Knaack seconded the Motion and upon roll call, the vote resulted as follows: Mr. Gooding, yes; Mr. Knaack, yes; Mr. Porter, yes; Mr. Weaver, yes; Mrs. Kaschak, yes.

Motion passed and adopted this 14th day of February, 2005.
